



2021 SKI TRIPS SCHEDULE & INFO

We have taken the following actions to reduce risks to Columbia Ski Club and our members:

- We have reduced the number of trips from 12 to 9 so there are less spaces to fill.
- We have negotiated more favorable cancellation terms with our vendors. While we hope we don't have to cancel any trips, we have more flexibility than ever this year to cancel most trips through the fall without penalty.
- We are not running any international trips due to heightened concerns and difficulty with international travel.
- All participants must comply with all federal, state, local, and CSC safety regulations, including but not limited to the use of face masks, following social distancing, frequent hand washing and/or use of hand sanitizer, and not traveling while sick.

Cancellation Policy still applies, but the \$25 CSC Fee will be waived once per person through 9/30/20. Additionally:

- If Columbia Ski Club chooses to cancel the trip [likely by the fall if it doesn't sell well], you will be refunded in full.
- If you cancel on your own, you'll be responsible for the CSC cancellation fee (if applicable) and unrecoverable expenses. Those unrecoverable expenses kick in later than usual. Leaders can give you the specific deadlines for each trip.
- If we are FORCED to cancel or shorten the trip due to travel restrictions or closures of the lodging property or resort, we'll do our absolute best to refund as much as possible and/or try to secure future travel credits.
- Trip insurance is always recommended! Do your research to understand policy options, deadlines, and coverage.

Signup procedures:

- All CSC Trip Sign Up policies, as defined on the Ski Trip Reservation Form, still apply.
- We are piloting electronic signups and payments for the Big Sky trip. This is completely optional.
